Excellence Boys Charter School does not have any significant changes to its educational program or governance structure to report. Two minor adjustments to our English language arts curriculum are briefly noted below:

- Excellence Boys Charter School has implemented the STEP reading assessment in grades K-4. The STEP assessment provides greater detail around the various elements of reading and literacy. The STEP replaces the DIBELS assessment we have used in the past.
- Excellence Boys Charter School has incorporated a guided reading program into our literacy instruction to enhance our focus around reading comprehension. Guided reading curricula are now in place across grades K-4.
