There have been no significant changes to the school's educational program this past year.

The following changes were made in the board membership. John DiPaolo, the Executive Director of Beginning with Children Foundation (BwCF), resigned his position with BwCF and as a CPCS board member and was replaced by Carol Matthews, COO at BwCF and a former CPCS Board member since 2004. Ghana-Imani Hylton and Herzen Clerge also resigned their positions as parent representatives because their children are no longer attending the school. Sabrina Blackwell and Carmen Robles were elected as new parent representatives. In addition, Clare Cusack was elected as a community board member.

This past year, the school requested an amendment to its charter to serve grades 6-8. Next year, the school will be expanding to serve 35 students in grade 6. The middle school, which will be located at PS 256 at 114 Kosciusko Street in Brooklyn, will eventually serve grades 4-8. The school will add one grade each year until reaching full enrollment in 2012-13.
