I. Call to Order

Meeting called to order at 6:54pm

II. Board Chair Report

Luis welcomed everyone to the fourth board meeting for the 2009-2010 school year. He stated that there will be an executive session only for board members after the business session.

Luis shared that he had three items on his agenda to discuss, 1) Board Resignations, 2) State cuts anticipated, and 3) 10th year celebration

<u>Board Resignations</u>- Luis shared that we have two resignations. Vincente Leon has moved to Peru because he was asked to start the operation of a bank (HSBC); he still wants to be helpful in any way possible. Chris Brown is getting married, and will do so in Austria. Initially he wanted to take a leave of absence, but unfortunately that is not available, so he had to resign. Chris also wishes to continue participating in any way he can. Luis motioned for acceptance of these resignations, which was then moved by Elizabeth and seconded by all.

<u>State cuts anticipated</u>- Luis commented on the fact that we have to plan a budget for the upcoming school year, 2010-2011, with a five percent cut; of which Vasthi, Courtnie and Luis met earlier this week to figure out. Luis stated that if the cuts are necessary, he feels it is better to cut something entirely than to make little cuts from here and there; it will be

necessary to think of big ticket items to cut. The administrative staff has been looking at "what if we added one more Kindergarten class." It is a very prospective idea because with the number of applications that we have been receiving, we can easily admit a Kindergarten class.

10th year celebration- Our 10th anniversary is coming up, and although we would like to celebrate it we are not going to create an extravagant event to raise millions; instead a modest event that can maybe raise \$20,000 -\$30,000. We have a basement in our building that we can use to keep a fundraiser, where we can showcase the school, and maybe have special presentations for our guests.

III. Head of School Report

Dr. Vasthi highlighted the following topics:

<u>Instruction</u>- We had our NYSED Site Visit on Thursday, February 4th, 2010 which went well. Some of the comments shared by the visitor, Ms. Kalimah Geter, were: "Lovely to see students engaged," "Good use of technology/media to support instruction," and "Liked the energy of the school and what was seen." In January promotion in doubt letters were sent out, from which first and second graders were identified for extra help and began Saturday Academy.

<u>Enrichment</u>- Amber Charter School will host "Seussical" which is our 1st musical performance. The performance is lead by Star Anderson with support from Eva Morales, Kathleen McCann, Janee Bignon, and Eunice Gonzalez. Performances are scheduled for Friday, March 12th at 6:00pm and Saturday, March 13th at 2:00pm. We look forward to seeing you!! Darlene was able to reach out and got for us a donation from a local business to support our partnership with El Museo del Barrio. Also, in February, t he Parent Association sponsored our Book Fair, in partnership with Barnes & Noble. Approximately 20% of the proceeds will be received.

<u>Staff and Faculty</u> – We have distributed and collected our Staff Preference forms. The feedback received is a 95% retention of faculty for school year 2010-2011. Also, Staff Developer, Nereida Morales, and Assistant Principal, Sandy McCarthy, attended SFA Experienced-Site Conference in Nashville, TN, in January, where they learned about improving implementation of the program.

<u>Student Recruitment</u>- Student Intent to Return forms were distributed and collected, referencing a retention rate of 98%, but this could be questionable. To date we have received 436 applications for the coming school year and we still have the rest of the month to go. Lottery will take place at the end of April.

Facility- COO is still pending as we are still working on it. The roof needs to be replaced. Dr. Vasthi commented that they have had several experts say the same thing, that the roof has lost "its legs." Darlene commented that they have taken bids, where some experts have cited \$300,000 as being the cost. Other bids have ranged from \$9800 to \$94,000. David Briggs commented that Darlene should forward the information to him so he can take a look at it. Luis stated that they looked at the budget and saw that it is something that needs to be done.
