Girls Preparatory Charter School of East Harlem ("GPCSEH") agreed to contract with a charter management organization, Public Preparatory Network, Inc. ("Public Prep") in November 2009. Public Prep is a charter management organization, created by the founders of the Girls Preparatory Charter Schools, which manages and supports a network of open-enrollment, free college preparatory charter schools.




Partnering with Public Prep allows GPCSEH to maintain a strict focus on its academic programs. Services from Public Prep include education and instruction-related services, student recruitment and admissions, curriculum, student assessment, accountability plan, professional development, special education, school policies and procedures, management and operation services, business administration, personnel and payroll, contracting of services, operations and human resources, equipment and information technology, public relations, and legal services. The partnership between GPCSEH and Public Prep permits the school to operate in an educationally and fiscally sound manner and will likely improve student learning and achievement.

On July 14, 2010, the Board of Regents approved the revision to the initial charter of the Girls Preparatory Charter School of East Harlem to include its contract with Public Prep.
