- LPBS has implemented the STEP reading assessment in grades K-4. The STEP assessment provides greater detail around the various elements of reading and literacy. The STEP replaces the DIBELS assessment we have used in the past.
- LPBS has incorporated a guided reading program into our literacy instruction to enhance our focus around reading comprehension. Guided reading curricula are now in place across grades K-4.


