Describe any significant changes to the school's educational program as well as its governance structure. If there are no changes, please indicate N/A.

There have been no changes to the school's governance structure, but we have enriched our program through the addition of two staff positions intended to support the academic achievement of our students. We have added an AIS Math Teacher/Math Coach and an AIS Reading Teacher/Literacy Coach. These teachers serve as resources to classroom teachers through their coaching and the AIS Support Center they have set up that contains student materials, supplies, and texts as well as professional resources. Their primary function is to work directly with students in one-on-one and small-group settings, mostly through pull-out but also through some push-in work. We have also added a daily phonemic drill routine to every classroom's schedule and have enriched reading comprehension work through the adoption of the Urban Education Exchange program to supplement our core ELA program.
