Re: First Year School Evaluation Visit

Dear Mr. Gallogly:

This letter outlines the State University of New York's Charter Schools Institute's observations and findings from its April 22, 2013 first year school evaluation visit to ROADS Charter School 1 ("ROADS 2"). The visit team consisted of Ron Miller, Ph.D., Executive Deputy Director for Accountability and Jeff Wasbes, Director of Performance and Systems Analysis. Allow me first to place this letter and the conclusions set forth below into context.

As with all SUNY authorized charter schools, on a periodic basis throughout the term of your school's charter the Institute conducts a number of formal site visits. The Institute reports in writing to the school on data gathered during these visits. Cumulatively, the information in letters such as this, as well as reports provided in later years, forms the foundation of qualitative data on the school's effectiveness. At the conclusion of the school's charter term, the Institute provides the State University of New York's Board of Trustees an analysis of your school's performance over the term of its charter that includes this qualitative information. The Institute makes a renewal recommendation for your school based on two components: the school's attainment of its academic Accountability Plan goals and evidence of the quality of the school's educational program collected during school evaluation visits.

At renewal, the Institute evaluates the academic, organizational, legal and fiscal aspects of the school's program using SUNY's Charter School Renewal Benchmarks (see attachment). A copy of the Renewal Benchmarks is included for your information. For formal school evaluation visits conducted prior to renewal, the Institute focuses on specific academic and organizational Renewal Benchmarks (called Qualitative Education Benchmarks). They provide a fixed standard for determining the quality of the academic program as the school progresses toward renewal.

For this first year visit, the Institute narrows the expectation for each benchmark in recognition of the school program's limited development. As a first year school is in its formative stage which has not yet completed an annual cycle, the visit focus is on the initial implementation of basic practices and procedures in each benchmark area. The center of attention is on the quality of instruction and related benchmarks, which heavily affect the progress that a school is able to demonstrate in meeting its Accountability Plan goals during the charter period. By the time a school comes to renewal, a school is expected to have moved from the beginning of implementation and the promise of future growth to full and effective implementation of a quality program.

Although the information provided in this letter is not intended as a prescription, the Institute would expect you to review thoroughly the issues highlighted below and, to the extent you find them helpful, use them to assist in guiding the school's leadership team to further develop the school's academic program or other aspects of the school. In this regard, please be aware that although the Institute takes very seriously the conclusions provided, we are cognizant of the fact that a one-day site visit may not yield information on all facets of a school's program.

Please find the team's findings from the first year visit below.

#### **Use of Assessment Data**

***ROADS 2 gathers assessment and evaluation data and uses it to improve the likelihood of students attaining course credit.***

- The school administers three times per year the Northwest Evaluation Association's Measure of Academic Progress ("NWEA MAP") assessments for tracking student growth. Teachers administer self-constructed daily, weekly and unit assessments to monitor student learning with limited oversight. The teacher-constructed assessments lack external validity to the Common Core standards. As such, they often do not reflect the rigor of the new standards.
- Using their assessment results, teachers maintain grade books that track student progress toward meeting the required outcomes for gaining course credit. Teachers and leaders do not yet use assessment results to determine the effectiveness of instruction and to develop alternative instructional strategies.
- Teachers regularly use assessment data to track individual progress toward meeting outcome requirements but have not used it to develop grouping or targeted learning interventions that address students' specific needs. The school relies on spiraled instruction to enable students to eventually master particular outcomes.

### **Curriculum**

***ROADS 2 is beginning to develop a school-wide set of curriculum documents to support its planning and delivery of instruction.***

- With the exception of social studies texts, the school chooses not to use commercial curriculum materials. Teachers have access to online resources and computer-assisted instruction programs.
- Using the state's Common Core Standards as the underlying framework, teachers have developed curriculum maps and pacing guides for the current course offerings throughout the school year in order to support development of daily lesson plans. By the third trimester, school leaders had streamlined the process by which teachers collaborate to develop these curriculum materials.
- Based on their own course and unit development, teachers know what to teach and when to teach it.

### **Pedagogy**

***Basic instruction is evident in some classrooms.***

- Teachers generally implement lesson plans with clearly stated objectives. Most lessons build on students' previous skills and knowledge and are relevant to daily life. At times, whole group instruction activities do not support the stated learning objective.
- Teachers regularly check for understanding about factual recall, but the responses do not affect the extent to which teachers clarify concepts or adjust the overall pacing. While co-teachers actively monitor student written work during the course of a lesson, there was limited evidence of their using techniques to evaluate learning at the end of the lesson.
- Teachers do not include opportunities in their lessons to challenge students with questions and activities that develop depth of understanding and higher-order thinking and problem solving skills. Students do not form predictions, develop arguments or use new knowledge and skills to investigate open-ended problems.
- Teachers do not maximize learning time. For example, teachers allow students to put away materials with time remaining during the period, listen to music and engage in texting during classroom activity. Teachers do prepare materials that are readily available and provide clear directions to students. Nevertheless, students spend unnecessary time copying statements from PowerPoint projection and often sit idly waiting for teachers to review their work.
- Teachers are developing classroom management techniques and routines to create a consistent focus on academic achievement. While they clearly communicate classroom rules and procedures, the school tolerates extensive low-level misbehavior.

### **Instructional Leadership**

***ROADS 2's instructional leadership does not yet adequately support the development of the teaching staff.***

- The school promotes a culture of learning and scholarship through a clearly articulated focus on outcome-based grading whereby students have to demonstrate mastery in ten outcomes in order to gain course credit. Nevertheless, their expectations for the delivery of instruction do not reflect the culture of learning necessary for preparing students.
- The school's instructional leadership provides limited coaching to support the development of the teaching staff because of the start-up demands related to the school serving an over-aged and under-credited student body.
- Instructional leaders provide sustained coaching to teachers who demonstrate inadequate pedagogical skills. The leaders coordinate with graduate school teacher supervisors and Teach for America coaches to support the development of the school's novice teachers. More experienced teachers receive limited support using the school's mini-observation rubric.
- The school conducted five days of professional development during the summer prior to the start of the school year. During the school year, teachers participate in weekly professional development sessions wherein outside experts provide workshops on using school resources and procedures, such as classroom management tools, approaches to lesson planning and computer assisted instruction.
- The school leaders determine teachers' professional development needs from classroom observations. On the basis of these findings, they have introduced a teacher inter-observation protocol in which teachers provide feedback to their peers on classroom practice. The effectiveness of this indirect approach will be determined in follow up formal classroom observations.
- Instructional leaders conduct three teacher evaluations during the school year based on the school's Targeted Teacher Effectiveness Rubric. While teachers are generally aware of the criteria, the leaders are still refining the evaluation process. Two struggling teachers received improvement plans this year, and leaders do not plan to invite all teachers back next year.

### **At Risk Students**

***ROADS 2 addresses the social emotional needs of at-risk students.***

- With an over-aged, under-credited population, the entire school population is at risk of academic failure. Forty eight percent of the students are court involved; 38 percent are students with disabilities; 14 percent are English language learners; 17 percent are in transitional housing; and 46 percent are involved in child protective services.
- The school deploys sufficient staff resources including: a full time director of students

support with a case management background who supervises six team advisors and one social worker; a network special education coordinator overseeing five special education teachers; and a classroom teacher with English as a second language certification.

- The school has a stated screening procedure in which grade level comprehension and word level skills determine ELA class placement. The school screens students' problem solving and computational skills to determine math class placement. The director of student support developed a social emotional screening tool that team advisors administer to every student. In order to make appropriate placements, the school has an elaborate instructional schedule.
- Special education teachers are full members of academic departments. As such, they collaborate with their colleagues in developing curriculum and lesson plans.

### **Organizational Capacity**

***The ROADS 2 organization does not yet adequately support the delivery of the educational program.***

- The ROADS network and the school have put in place an administrative structure with staff, operational systems and procedures to support the school in carrying out its academic program. The network supports the school in operations, in finance and human resources, and the school employs school-based operations staff. Further, the network and school have an organizational structure for providing social-emotional support services. Nevertheless, the network does not yet directly support the development of the school's instructional delivery systems.
- The school environment is generally safe and transitions between classes are orderly; however, continual student texting and use of personal music players undermines the orderliness within classrooms. These activities appear to be the outcome of a tacit negotiated truce of acceptable behavior between teachers and students. The school suspended 30 students in the first three months of the school year; the school has had about half as many suspensions in the last three months. Leaders attribute the change to students more clearly understanding behavioral expectations
- The school has allocated extensive resources to serving students' social emotional needs. Teachers have access to ample instructional technology. Students have access to computers and calculators, but the school lacks sufficient high-interest reading material.
- The school has begun to create some protocols necessary to ensure a well-functioning school organization. School leaders have begun to explore implementing an integrated interim assessment program. While they have introduced a focused approach to teacher evaluation, the formal and informal evaluations are not adequately integrated with pedagogical development. More importantly, the instructional leaders have not begun to provide systematic coaching to develop the staff's professional competence.

### **Board Oversight**

***The ROADS 2 school board provides oversight to the total educational program, but has not yet monitored student achievement.***

- The board has an adequate skill set with expertise in finance, governance, charter schools and administering programs to serve the social emotional needs of at-risk youth. The board functions with finance, governance, school design and performance, and executive committees. The finance and school design and performance committees are the most active. After a deliberate vetting process, the board adds new members to increase its skill diversity.
- The board has a clear understanding of its governance responsibilities; the school design and performance committee leads the board in thoughtful discussion on differentiating the school's services to address the needs of the school's various student sub-populations.
- The network works with the school principal on developing a school performance dashboard, which currently includes as its key metrics credit accumulation, attendance, suspensions and discipline. The board follows up on the principal's reports by evaluating aspects of program implementation.
- The board plans to conduct a year-end evaluation of the principal, but it has not yet determined the method and content of the evaluation. In the absence of reliable student assessment data and with limited data on credit accumulation, the board has thus far relied on an external agency's evaluation of the principal's leadership qualities.
- The board recognizes the importance of expanding the network's capacity to support development of the school's instructional delivery systems.

These conclusions constitute the beginning of your school's record of progress toward meeting the standards constituted in SUNY's Renewal Benchmarks. The Institute conducts formal evaluation visits multiple times during each school's initial charter term and at least once during subsequent charter terms. The cumulative evidence collected during these school evaluation and renewal visits, as well as the school's record of success at meeting Accountability Plan goals becomes part of the record that informs the Institute's renewal recommendation to the SUNY Trustees.

The number of school evaluation visits the Institute will conduct before renewal depends on a variety of factors. In addition to adhering to a regular schedule of visits, concerns raised in the conclusions of previous visits, the school's progress toward meeting Accountability Plan goals and emergent legal and compliance issues may affect the frequency and timing of the visits.



## **State University of New York Charter Renewal Benchmarks**

*Version 5.0, May 2012*

---

### Introduction

The State University of New York Charter Renewal Benchmarks<sup>1</sup> (the "SUNY Renewal Benchmarks") serve two primary functions at renewal:

- They provide a framework for the Charter Schools Institute (the "Institute") to gather and evaluate evidence to determine whether a school has made an adequate case for renewal. In turn, this evidence assists the Institute in deciding if it can make the required legal and other findings in order to reach a positive recommendation for renewal. For example, the various benchmarks that the Institute uses to determine whether the school has had fiscally responsible practices in place during the last charter period allow the Institute to determine with greater precision whether the school will operate in a fiscally sound manner during the next charter period, a finding that the New York Charter Schools Act requires the SUNY Trustees to make.
- At the same time that the SUNY Renewal Benchmarks provide a framework for the Institute to collect and review evidence, they also provide the school with a guide to understanding the Institute's evaluative criteria. As the Institute uses the SUNY Renewal Benchmarks (or some sub-set of them) as the framework for conducting its ongoing school evaluation visits, school leaders should be fully aware of the content of the Benchmarks at the time of renewal.

The SUNY Renewal Benchmarks are organized into four inter-connected renewal questions that each school must answer when submitting a renewal application. The benchmarks further reflect the interwoven nature of schools from an academic, organizational, fiscal and/or legal perspective. For example, the Institute could reasonably place many of the academic benchmarks under the heading of organizational effectiveness. More generally, some redundancy exists because the

<sup>1</sup> Research on public school reform, known as the effective schools movement, has embraced the premise that, given certain organizing and cultural characteristics, schools can teach all children the intended curriculum and hold them to high academic standards. Over the decades, the accumulated research into effective schools has yielded a set of common characteristics that all effective schools share. These characteristics are so consistently prevalent among successful schools that they have come to be known as the *Correlates of Effective Schools*. The Renewal Benchmarks adapt and elaborate on these correlates.

Institute looks at the same issue from different perspectives.

Precisely how the Institute uses the SUNY Renewal Benchmarks, during both the renewal process and throughout the charter period, is explained in greater detail in the *Practices, Policies and Procedures for the Renewal of Charter Schools Authorized by the State University of New York* (the “SUNY Renewal Practices”), available on the Institute’s website at: [www.newyorkcharters.org/schoolsRenewOverview.htm](http://www.newyorkcharters.org/schoolsRenewOverview.htm). Responses to frequently asked questions about the Institute’s use of the SUNY Renewal Benchmarks appear below:

- The Institute does not have a point system for recommending renewal. A school cannot simply tally up the number of positive benchmark statements in order to determine the Institute’s recommendation.
  - Some benchmarks are weighed more heavily than others. In particular, the Institute gives the greatest weight to how well the school has met its academic Accountability Plan goals.
  - Despite the fact that the Accountability Plan comprises only a single benchmark, a school’s performance on that benchmark is critical. In fact, it is so important that while the Institute may recommend non-renewal for fiscal and organizational failures (if sufficiently serious), excellence in these areas will not excuse poor academic performance.
- The Institute does not use every benchmark during every kind of renewal review, and how the benchmarks are used differs depending on a school’s circumstances. For example, the Qualitative Education Benchmarks (Benchmarks 1B-1F, 2C and 2D) are given far less weight in making a renewal decision on schools that the Institute has previously renewed. Similarly, less weight is accorded to these benchmarks during an initial renewal review where a school has consistently met its academic Accountability Plan goals.
  - The Institute also may not consider every indicator subsumed under a benchmark when determining if a school has met that benchmark, given the school’s stage of development or its previous track record.
- Aside from Benchmark 1A on academic Accountability Plan goals (which is singular in its importance), no school should fear that a failure to meet every element of every benchmark means that it is not in a position to make a case for renewal. To the contrary, the Institute has yet to see a school that performs perfectly in every respect. The Institute appreciates that the benchmarks set a very high standard collectively. While the Institute certainly hopes and expects that schools aim high, it is understood that a school’s reach will necessarily exceed its grasp in at least some aspects.

In this fifth edition of the SUNY Renewal Benchmarks, the Institute has made some revisions to the Qualitative Education Benchmarks, namely those benchmarks used for ongoing school evaluation visits, to streamline the collection of evidence. For example, the Institute has incorporated Student Order and Discipline into Pedagogy, and Professional Development into Instructional Leadership. The Institute has rewritten some of the overarching benchmark statements to capture the most

salient aspects of school effectiveness, organizational viability, legal compliance, and fiscal soundness. Some of the bulleted indicators within benchmarks have been recast or eliminated. Finally, the Institute has added some indicators to align the benchmarks with changes in the Charter Schools Act (e.g., provisions in meeting enrollment and retention targets when assigned and abiding by the General Municipal Law).

It is important that the entire school community understand the renewal process. All members of a school's leadership team and board should carefully review both the SUNY Renewal Benchmarks and the SUNY Renewal Practices.
