Veronica Almedina and **Kirsys Gomez** have served as the Co-Chief Executive Officers of Amber Charter Schools since July 1, 2022. **Ms. Gina Mellusi** has served as the elementary school's principal since 2020. **Ms. Mia Thomas** has served as the principal of the middle school since September 2021.

SCHOOL OVERVIEW

Amber Charter Schools, established in 2000, is among the first charter schools in New York State, deeply rooted in the New York City community. The school takes pride in catering to a diverse student body, reflecting the cultural richness of the city. This diversity is celebrated as a strength, and efforts are made to establish an inclusive community where every student feels valued and respected. Active engagement with families and the broader community is prioritized to build strong partnerships that support student learning and well-being.

The school focuses on academic excellence and holistic child development, emphasizing literacy, mathematics, science, arts, and relevant social-emotional learning for all students.

There is a deep commitment to providing a rigorous, well-rounded education, preparing students from diverse backgrounds for success in high school, college, and beyond. The elementary school campus has proudly expanded its Integrated Co-Teaching (ICT) model to cater to diverse learners. Courses that provide academic and financial support for various tests, such as the Test for Admission into Catholic High Schools (TACHS), algebra and science regents for 8th graders, and the Specialized High Schools Admissions Test (SHSAT) will now be a mainstay at Amber Kingsbridge as we prepare our students to be competitive in high school.

Additionally, 10% of our 8th graders (6/61 students) qualified for the DREAM program. DREAM-Specialized High School Institute (SHSI) is an academic test prep program designed to prepare eligible seventh-grade NYC public or charter school students to take the Specialized High School Admissions Test (SHSAT) in 8th grade. Students selected to participate must have scored 3.2 or above in the ELA and Math state exams and reside or attend school in one of the eligible NYC school districts. The DREAM-SHSI program works to strengthen student math and reading performance, enhance their test-taking skills, engage students in project-based and community-building learning, and provide further High School guidance.

In June, the school observed the success of its efforts as most of the eighth graders, many of whom have been with Amber since kindergarten and first grade, were admitted to top parochial, private, public, and screened-public schools. 98% of Amber 8th grade students received an offer to one of their top three schools. 91% of 8th grade students received an offer to one of their top two schools, and 72% of Amber 8th graders received an offer to their first choice for high school. Former Amber students attend esteemed schools such as Fordham Prep, Cardinal Hayes, Beacon High School, International Leadership High School, School in the Square, and High School of Fashion Industries.

To support our programming and offerings, we are continuously recruiting, training, and retaining highly qualified staff to assist us in our scholastic endeavors. Some efforts made this past year include:

- Continued development and refinement of network-wide pacing calendars and scope and sequences for all content areas, including specialties aligned across campuses
- Continued development and refinement of network-aligned assessments (unit, module, mock, and benchmark), rubrics, and answer keys
- Targeted tutoring that is available thanks to a grant from the Robin Hood Foundation

- Fourth annual Leadership Institute that was attended by all chiefs, directors, managing directors, and school leadership team members, focused this year on the Amber Core Value of Honesty, collaborative planning, and best practices for accountability initiatives
- At minimum, three half or full-day network-wide trainings throughout the year (depending on role) for all school leadership team members to collaborate, analyze data, develop and refine leadership skills, and plan for upcoming events/initiatives
- We have partnered with consultants trained by the Noble Story Group for personal leadership development for the fourth year. These consultants support our principals/assistant principals and assist them in further developing their self-awareness and emotional intelligence, contributing to a deeper understanding of how they influence their leadership (for example, identifying and naming personal triggers).
- Continued implementation of Magnetic Reading Foundations (Science of Reading aligned program) for kindergarten, first, and second graders, including on-site visits and trainings from a Magnetic Reading curriculum specialists
- Continued development and creation of a culturally relevant, accurate, and New York State aligned K-4 social studies curriculum, developed by a cross-functional Amber staff team
- Transition to a new testing and data analysis platform - LinkIt - that closely mimics the New York State Nextera computer-based testing platform (beginning in February, all mocks and unit tests were administered on the platform, staff were also able to create their own quizzes and practice materials on the platform)

On BEDS day in 2024-25, Amber Kingsbridge served 720 students in grades K-8. Of the total student body enrolled, 52% were female and 48% were male. 81.5% of students identify as Hispanic, while 12.6% identify as Black. 7.6% of students identify as another race/s and/or ethnicity. A large majority of our students (84.3%) were considered economically disadvantaged (with 9.3% categorized as homeless). 21.3% had a disability, and 9.2% were considered English Language Learners (with another 6.9% categorized as former ELLs).

Launched in 2021, Kingsbridge Middle School is becoming well-known in the Inwood neighborhood. The attrition numbers are stable, and Kingsbridge Elementary, a long-standing institution in the area, continues to attract and retain students successfully. Throughout the 2024-25 school year, we consistently enrolled students in all grade levels.

GOAL 1: ENGLISH LANGUAGE ARTS

All students at Amber Charter School will be proficient readers and will make strong yearly progress toward mastery of English-language reading skills.

The school administered the New York State Testing Program English Language Arts (“ELA”) assessment to grades 3-8. In addition, the school administered iReady assessments to its K-8 students. Results for these grade levels are presented below.

BACKGROUND

Amber Charter Schools has been using Houghton Mifflin Harcourt’s [Into Reading](#) literacy curriculum for grades K-5 since the 2020-2021 school year. Amber Charter School Kingsbridge Middle School has been using Houghton Mifflin Harcourt’s Into Literature (grade 6-8) since its inception, and the expanding Amber Charter School East Harlem Middle School will align and also use the Into Literature curriculum for grades 6-8. Both of these curriculums aligned to the New York State Next Generation Standards.

While Amber Charter Schools has found success in implementing HMH’s Into Reading curriculum over the past several years in the elementary grades K-4, we have also had to be responsive to student and staff data and needs, particularly coming out of the pandemic. This prompted Amber Charter Schools to adopt and utilize a new foundational skills curriculum (phonics, phonological awareness) for grades K-2 - Magnetic Reading Foundations from Curriculum Associates. For clarity, since the 2023-2024 school year, all Amber Charter Schools across grades K-2 now use Magnetic Reading Foundations 30 minutes daily as their ELA foundational skills block. HMH Into Reading is used for the remaining 60 minutes of daily ELA, focusing on vocabulary, grammar, writing, and comprehension.

Our August Summer Institute and ongoing professional development opportunities throughout the school year reflect our commitment to supporting the growth of our faculty. Each year, we tailor professional development plans to meet the unique needs of our staff, fostering their individual and collective advancement. By providing comprehensive feedback and emphasizing cross-campus alignment, we aim to enhance our network's educational practices and pedagogy.

ELEMENTARY AND MIDDLE ELA

ELA Measure 1 - Absolute

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State English language arts examination for grades 3-8.

ELA Measure 2 - Absolute

Each year, the school’s aggregate Performance Index (“PI”) on the State English language arts exam will meet that year’s state Measure of Interim Progress (“MIP”) set forth in the state’s ESSA accountability system.

In New York State, ESSA school performance goals are met by showing that an absolute proportion of a school’s students who have taken the English language arts test have scored at the partially proficient, or proficient and advanced performance levels (Levels 2 or 3 & 4). The percentage of students at each of these three levels is used to calculate a PI and determine if the school has met the MIP set each year by the state’s ESSA accountability system. To achieve this measure, all tested students must have a PI

value that equals or exceeds the state’s 2024-25 English language arts MIP for all students of **117.3**. The PI is the sum of the percent of students in all tested grades combined scoring at Level 2, plus two times the percent of students scoring at Level 3, plus two-and-a-half times the percent of students scoring at Level 4. Thus, the highest possible PI is 250.²

RESULTS AND EVALUATION

For the 2024-25 school year, the New York State MIP (Measure of Interim Progress) is set at 117.3. Amber Kingsbridge exceeded this benchmark by over 38 with a PI of **156.25**.

Notably, the State's MIP for Hispanic and Black students stands at 109 and 111.6, respectively. 94% of our testing grades (grades 3-8) population identify as Hispanic or Black. Amber's overall MIP surpassed the State’s MIP for Hispanic students by 47.25 and for Black students by 44.65. We take great pride in these achievements.

ELA Measure 3 - Comparative

Each year, the percent of all tested students who are enrolled in at least their second year and performing at proficiency on the state English language arts exam will be greater than that of all students in the same tested grades in the school district of comparison.

A school compares tested students enrolled in at least their second year to all tested students in the public school district of comparison. Comparisons are between the results for each grade in which the school had tested students in at least their second year at the school and the total result for all students at the corresponding grades in the school district.³

ELA Measure 4 - Comparative

Each year, the school will exceed its predicted level of performance on the state English language arts exam by an effect size of 0.3 or above (performing higher than expected to a meaningful degree) according to a regression analysis controlling for economically disadvantaged students among all public schools in New York State.

The Institute conducts a Comparative Performance Analysis, which compares the school's performance to that of demographically similar public schools statewide. The Institute uses a regression analysis to control for the percentage of economically disadvantaged students among all public schools in New York State. The difference between the school's actual and predicted performance, relative to other schools with similar economically disadvantaged statistics, produces an Effect Size. An Effect Size of 0.3, or performing higher than expected to a meaningful degree, is the target for this measure. Given the timing of the state's release of economically disadvantaged data and the demands of the data analysis, the 2024-25 analysis is not yet available. This report contains 2023-24 results.⁴

ELA Measure 5 - Growth

Each year, under the state's Growth Model, the school's mean unadjusted growth percentile in English language arts for all tested students in grades 4-8 will be above the target of 50.

METHOD

Given the timing of the state's release of Growth Model data, the 2024-25 analysis is not yet available. This report contains 2023-24 results, the most recent Growth Model data available.⁵

This measure examines the change in performance of the same group of students from one year to the next and the progress they are making in comparison to other students with the same score in the previous year. The analysis only includes students who took the state exam in 2023-24 and also have a state exam score from 2022-23 including students who were retained in the same grade. Students with the same 2022-23 score are ranked by their 2023-24 score and assigned a percentile based on their relative growth in performance (student growth percentile). Students' growth percentiles are aggregated school-wide to yield a school's mean growth percentile. In order for a school to perform above the target for this measure, it must have a mean growth percentile greater than 50.

Our overall average mean growth percentile from the 2023-2024 school year was 43.3—missing the target by 6.7. We look forward to seeing this data for the 2024-2025 results, especially as we know we made significant growth this past school year.

This year, our students achieved more than average typical growth in ELA in measures 1 and 2. We are particularly proud of the growth our “lowest initial achievers”, or those students who were two or more

grade levels behind, made at 156.5% median growth. However, our students with disabilities did not meet the goal, and a quarter of students enrolled for 2+ years were at the mid-on grade level or above by the end of the year on i-Ready. We are concerned about these areas and will continue to focus on them throughout the 2025-2026 school year, as noted in the ELA action plan. See the table below for additional information on the percentages of students who achieved mid-on-grade level or above.

The table above shows the median percentages of annual typical growth, which are cause for celebration overall in grades K-8. Our goal in every grade is at least 100% median typical growth, and we exceeded that in eight of the nine grades.

Furthermore, middle school was a significant area of concern last year, but we have seen marked improvement in grades 5-7 compared to last year's median percent of annual typical growth. In the school year 2023-2024, 5th grade's median typical growth was 42.5%, 6th's was 73.5%, and 7th's was 60%. This year, 6th-7th grade's median typical growth is well over 100%, and 5th grade's has increased by over 40%. We look forward to continuing to build on this strong foundation.

SUMMARY OF THE ELA GOAL

In summary, we met two out of four internal i-Ready measures. In terms of ELA NYS Test performance, we surpassed the MIP and District comparison goals, but did not yet meet goal 1 of 75% proficiency for those in their 2nd+ year at Amber. We are approaching this goal, however, at 67% proficiency for students who've been at Amber for 2+ years, and 3rd grade exceeded this goal with 89% proficiency. We met the goal for measure 4 with an effect size greater than .3 (.58 effect size), but we did not meet the measure 5 goal in the 2023-2024 school year. To address the stagnation or lack of growth and to ensure we are meeting all goals in future years, the action plan for ELA is listed below.

EVALUATION OF ELA GOAL

New York State Assessment:

Last year (spring 2024), 51% of students enrolled in at least their second year were proficient on the ELA State Test. This year (spring 2025), we've increased 16% to achieve 67% proficiency for students grades K-8 in at least their second year at Amber. This is great growth that we are very proud of, and we will continue to strive for another 8% increase this year to reach our 75% proficiency goal.

Additionally, we not only outperformed the district collectively in grades 3-8, but outperformed the district 5/6 grade levels (all grades except 7th grade). Some grades outperformed their district's grade-level proficiency score by double digits - including by an additional 45% in 3rd grade, over 25% more in 4th grade, and over 20% more in 8th grade. These are huge achievements.

i-Ready:

We will continue to strive to increase the percentage of students demonstrating mid-on grade level proficiency according to i-Ready. Despite not meeting the 75% goal, we do, however, continue to show more than average annual growth for all students and those who are the most behind. Additionally, not captured in the mid on-grade level numbers, are the percentages of students who are considered "early on grade level" on i-Ready. Both mid-on grade level and early-on grade level are considered "in the green" or on/approaching grade level, whereas students "one grade level below" are "in the yellow". When we look at the entire green bar (mid-on and early-on grade level) numbers, we are much closer to our 75% goal. 60% of all students in grades K-8 scored mid-on or early-on grade level on the end of year i-Ready test in 2025 (compared to 29% mid-on grade level only).

ADDITIONAL CONTEXT AND EVIDENCE

Amber, prior to the pandemic has been a premier school for staff retention--especially that of teachers. As we focus on academic growth, we are also making efforts to recruit and maintain the most effective educators aligned with our mission. As we continue to navigate and strategize staffing, we will continue to provide our staff with targeted professional development opportunities. In addition, as mentioned in the overview, we have put great effort into our talent and human resources team. We know that the best educators make a difference in teaching and learning. We cite staffing as a significant factor in student achievement.

Computer-based testing was expanded to all testing grades 3-8 at Amber this year (compared to just grades 5-8 the previous year). We suspect navigating the new system was an obstacle for some children. Despite the challenges described and the need to increase the percentage of students demonstrating mid-on-grade level, we continue to show more than average annual growth for all students and those who are the most behind.

ELA ACTION PLAN

While we recognize that progress has been made in our ELA achievement this past year, we still intend for our students to better demonstrate their knowledge through the NYS and iReady assessments. Our plan for 2025-20256 involves reinforcing our previous strategies and improving our current practices with a multi-streamed approach.

Enhanced reading intervention practices:

According to Scarborough's Reading Rope, skilled and accurate reading with strong comprehension is the result of intertwining two main "strands" of reading - language comprehension and word recognition. We have observed that many elementary students, both lower and upper grades, struggled with the word recognition aspect of skilled reading, particularly following the return to in-person learning after the pandemic.

Additionally, we have seen an increase in the number of new or early career teachers at Amber staff. While Into Reading includes a foundational skills component in their curriculum, teachers and leaders found the material to be dense and challenging to navigate. This led to inconsistencies in the

implementation of foundational skills lessons in K-2 classrooms, which ultimately affected grades 3-4. To address this, we continue to implement Magnetic Reading Foundations curriculum. We've found Magnetic Reading Foundations to be a systematic, straightforward, and effective program. We've seen an increase of 16% of 1st grade students considered early-on or mid-on grade level in phonics i-Ready from before using Magnetic Reading Foundations to two years after implementing the curriculum. In 2nd grade, we've seen an increase of 20% of students considered early-on or mid-on grade level in i-Ready phonics within that same time.

While we've seen excellent results in first and second grade, we have not seen that same growth in Kindergarten on i-Ready phonics. There continues to be about 75% of kindergarten students considered early-on or mid-on grade level in phonics i-Ready at the end of the year. To address this stagnation, beginning in the 2025-2026 school year, kindergarten will implement 45 minutes of Magnetic Reading Foundations (instead of 30 minutes) daily in order to implement the full scope of lessons outlined in the curriculum. We have also planned to have the Curriculum Associates trainer, an expert in the Magnetic Reading Foundations curriculum, do three, full-day site visits at each elementary campus this upcoming school year. The full-day visits included observations, coaching, training, and planning.

Furthermore, to address gaps in foundational skills knowledge for students in grades 3+, last year, school year 2024-2025, was the first year that we implemented a new reading assessment, the Amber Reading Assessment (ARA), in place of the DRA. The Amber Reading Assessment is an assessment that pulls from both DIBELS (Oral Reading Fluency passages) and Really Great Reading's Foundational Skills Assessment, Beginning and Advanced Decoding Surveys. In grades K-2 on the ARA, there are specific elements that are administered to all students regardless of i-Ready score to ensure we are keeping a pulse on foundational skill acquisition. Then, for grades K-8, if a student scores below grade level on i-Ready phonological awareness or phonics, there is additional testing done with the ARA to better understand those gaps in foundational skills. This ARA data is then used for RTI, ENL, SETSS, and small group/"What I Need" instruction.

Additional academic support:

To enhance the core curriculum and provide rigorous and structured options for teachers, we utilize supplemental platforms such as Raz-Kids, [Nearpod](#), [Newsela](#), [BrainPop](#), and [Standards Plus](#) as a part of our Response to Intervention framework. Academic intervention staffing at both schools, including SETSS, ESL, AIS, tutoring, and Title I Reading teachers, along with teacher assistants in grades K-2, tutors in grades 3-5, and Student Support Associates remains intact.

Kingsbridge will continue another year using its grant funding from the Robinhood Foundation to provide small-group targeted tutoring in a 4:1 ratio. By unpacking the state test and i-Ready data by grade, class, and students, we will intentionally create groups and assign tutors/staff and lessons to those groups. With this targeted approach, we are hopeful that these efforts will contribute to significant progress.

Furthermore, this year across the network, we are partnering with an outside consultant (Structured Literacy Solutions) with an expertise in literacy to audit our current literacy practices K-8 and create both a short-term and long-term vision for literacy programming at Amber. Additionally, this consultant will also be helping us build out our novel studies program, ranging from 2nd-8th grade. 3rd grade and 6th grade will be intentional grades of focus that will receive training and support in novel study unpacking, lesson unpacking, and intensive live coaching during implementation of the novel study units.

Increased and intentional instructional minutes:

This year, our academic priority is to ensure that students are doing the heavy lifting within and across all lessons. Part of students doing this heavy lifting is ensuring that students have 10-15 minutes of daily deliberate, independent practice within ELA blocks.

Additionally, we will continue to have one 30 minute ELA RTD block each week in grades K-3 for teachers to revisit skills and concepts with which students need additional support. In both third and fourth grade, we have also carved out intentional test prep/spiral review blocks for an additional 45-60 minutes each week.

Lastly, we know that close-reading skills are critical. We launched implementation of close-reading skills and practice last year (school year 2024-2025) in pockets, but it was often difficult to make time. To mitigate this issue, we've included a 26 day close reading intensive unit in the pacing for 3rd-8th grade.

Computer-based testing exposure:

The entire network will continue taking all module and unit assessments in Math and ELA on a computer-based testing platform, LinkIt, to help prepare staff and students for the NYS test online.

Additional Professional Development:

We will continue with network-wide data analysis days to allow cross-campus data meetings with clear protocols and next steps. This will include looking at data across subgroups of students (such as students with disabilities) to ensure we are fostering environments conducive to growth for all students. SETSS and intervention teachers are a part of these data analysis days as well. We are confident that these efforts and an intentional focus on responding swiftly to data throughout the school year, in tandem with intentional coaching, support, and feedback, will result in significant growth.

GOAL 2: MATHEMATICS

All students at Amber Charter School will become proficient in math and will make strong yearly progress toward mastery of mathematical skills.

BACKGROUND

Amber Charter Schools has been using Houghton Mifflin Harcourt's Into Math curriculum for grades K-5 since the 2020-2021 school year. Additionally, Amber Charter School Kingsbridge Middle School has been using Houghton Mifflin Harcourt's Into Math and Into Algebra since the 2023-2024 school year.

Before the 2023-2024 school year, Amber Charter School Kingsbridge Middle School and Amber Charter School Inwood piloted a different mathematics curriculum, Achievement First Navigator. Although the Achievement First Navigator mathematics curriculum received a "meets expectations" rating from Ed Reports, Amber's teachers and leaders found the curriculum to be more complex and challenging to implement. This was especially true during the 2021-2022 pilot of the Achievement First Navigator curriculum, as there was a large staff turnover and many teachers and leaders were new to education due to the challenges posed by COVID-19.

At the same time, Amber Charter School East Harlem and Kingsbridge Elementary School were using the HMH Into Math curriculum. Teachers and leaders at these campuses found it easier to navigate the HMH lesson structure and utilize the resources provided for differentiated learning, which was crucial as

Each year, we tailor professional development plans to meet the unique needs of our staff, fostering their individual and collective advancement. By providing comprehensive feedback and emphasizing cross-campus alignment, we aim to enhance our network's educational practices and pedagogy.

ELEMENTARY AND MIDDLE MATHEMATICS

Math Measure 1 - Absolute

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State Mathematics examination for grades 3-8.

Math Measure 2 - Absolute

Each year, the school's aggregate Performance Index ("PI") on the state mathematics exam will meet that year's state Measure of Interim Progress ("MIP") set forth in the state's ESSA accountability system.

METHOD

In New York State, ESSA school performance goals are met by showing that an absolute proportion of a school's students who have taken the mathematics test have scored at the partially proficient, or proficient and advanced performance levels (Levels 2 or 3 & 4). The percentage of students at each of these three levels is used to calculate a PI and determine if the school has met the MIP set each year by the state's ESSA accountability system. To achieve this measure, all tested students must have a PI value that equals or exceeds the state's 2024-25 mathematics MIP for all students of **119.4**. The PI is the sum of the percent of students in all tested grades combined scoring at Level 2, plus two times the percent of students scoring at Level 3, plus two-and-a-half times the percent of students scoring at Level 4. Thus, the highest possible PI is 250.

RESULTS AND EVALUATION

For the 2024-25 school year, the New York State MIP (Measure of Interim Progress) is set at 119.4 for Mathematics. Amber Kingsbridge exceeded this benchmark by over 27 with a PI of **146.95**.

Notably, the State's MIP for Hispanic and Black students stands at 105.8 and 102.6, respectively. 94% of our Kingsbridge student population falls within these demographics. Amber's overall MIP surpassed the State's MIP for Hispanic students by 41 and for Black students by 44. We take great pride in these achievements.

Math Measure 3 - Comparative

Each year, the percent of all tested students who are enrolled in at least their second year and performing at proficiency on the state mathematics exam will be greater than that of all students in the same tested grades in the school district of comparison.

METHOD

A school compares tested students enrolled in at least their second year to all tested students in the public school district of comparison. Comparisons are between the results for each grade in which the school had tested students in at least their second year at the school and the total result for all students at the corresponding grades in the school district.

METHOD

The Institute conducts a Comparative Performance Analysis, which compares the school's performance to that of demographically similar public schools statewide. The Institute uses a regression analysis to control for the percentage of economically disadvantaged students among all public schools in New York State. The difference between the school's actual and predicted performance, relative to other schools with similar economically disadvantaged statistics, produces an Effect Size. An Effect Size of 0.3, or performing higher than expected to a meaningful degree, is the target for this measure. Given the timing of the state's release of economically disadvantaged data and the demands of the data analysis, the 2024-25 analysis is not yet available. This report contains 2023-24 results.⁷

Grade 4 met the target, exceeding it by over .3. Our overall effect size from the 2023-2024 school year was -.06, missing the .3 or above target. We look forward to seeing this data for the 2024-2025 results, especially as we know we made significant growth this past school year.

Math Measure 5 - Growth

Each year, under the state's Growth Model, the school's mean unadjusted growth percentile in mathematics for all tested students in grades 4-8 will be above the target of 50.

METHOD

Given the timing of the state's release of Growth Model data, the 2024-25 analysis is not yet available. This report contains 2023-24 results, the most recent Growth Model data available.⁸

This measure examines the change in performance of the same group of students from one year to the next and the progress they are making in comparison to other students with the same score in the previous year. This year, our students achieved more than average typical growth in Math in measures 1 and 2. We are particularly proud of the growth our “lowest initial achievers”, or those students who were two or more grade levels behind, made at 134% median growth. However, our students with disabilities missed the goal of 129% growth by 10% (achieved 119% growth). About a quarter of students enrolled for 2+ years were at the mid-on grade level or above by the end of the year on i-Ready. We will continue to strive to meet and exceed all goals moving forward. The table above shows the median percentages of annual typical growth, which are cause for celebration overall in grades K-8. Our goal in every grade is at least 100% median typical growth, and we exceeded that in eight of the nine grades (all except 3rd grade).

Furthermore, middle school was a significant area of concern last year, but we have seen marked improvement in grades 5-6 compared to last year's median percent of annual typical growth. In the school year 2023-2024, 5th grade's math median typical growth was 28% and 6th's was 52%. This year, 5th-6th grade's median typical growth is over 100%. 5th grade's growth has increased by 80% and 6th grade's growth by over 100%. We look forward to continuing to build on this strong foundation.

SUMMARY OF THE MATHEMATICS GOAL

In summary, we met one two of four internal i-Ready measures, with one missed measure by 10% (and still over 100% growth). In terms of Math NYS Test performance, we surpassed the MIP and District comparison goals (some grades outperformed the district by 25%, 30%, and even 40%!), but did not yet meet the goal 1 of 75% proficiency for those in their 2nd+ year at Amber. We are approaching this goal, however, at 61% proficiency, and both 3rd and 4th grade exceeded this goal with 82% and 87% proficiency. We did not meet the goal for measure 4 with an effect size greater than .3. We also did not meet the measure 5 goal in the 2023-2024 school year. To address the stagnation or lack of growth and to ensure we are meeting all goals in future years, the action plan for Math is listed below.

EVALUATION OF THE MATHEMATICS GOAL

New York State Assessment:

Last year (spring 2024), 41% of students enrolled in at least their second year at Amber were proficient on the Math State Test. This year (spring 2025), we've increased 20% to achieve 61% proficiency for students grades K-8 in at least their second year at Amber. This is great growth that we are very proud of, and we will continue to strive for another 14% increase to reach our 75% proficiency goal.

Additionally, we not only outperformed the district collectively in grades 3-8 by 20%, but outperformed the district in 3rd, 4th, 6th, and 8th grade levels (5th grade performed the same as the district and 7th grade was 2.8% below the district). Some grades outperformed their district's grade-level proficiency score by double digits - including by an additional 35% in 3rd grade, over 40% more in 4th grade, over 25% more in 6th grade, and over 20% more in 8th grade. These are huge achievements.

Lastly, we are very proud of our 8th grade Algebra 1 students. Every student who took the Regents exam in June passed.

i-Ready:

We will continue to strive to increase the percentage of students demonstrating mid-on grade level proficiency according to i-Ready. Despite not meeting the 75% goal, we do, however, continue to show more than average annual growth for all students and those who are the most behind. Additionally, not captured in the mid on-grade level numbers, are the percentages of students who are considered "early on grade level" on i-Ready. Both mid-on grade level and early-on grade level are considered "in the green" or on/approaching grade level, whereas students "one grade level below" are "in the yellow". When we look at the entire green bar (mid-on and early-on grade level) numbers, we are closer to our 75% goal. 53% of all students in grades K-8 scored mid-on or early-on grade level on the end of year i-Ready test in 2025 (compared to 20% mid-on grade level only).

ADDITIONAL CONTEXT AND EVIDENCE

As mentioned above in the ELA section, we will continue to navigate and strategize staffing, ensure we are recruiting and retaining effective educators, as well as providing purposeful and targeted ongoing professional development.

In both third and fourth grade, we have also carved out intentional test prep/spiral review blocks for an additional 45-60 minutes each week.

Lastly, Amber recognizes the need to improve our students' math fluency skills. In addition to the 90 minutes of math instruction per day, we will continue to have an additional 20 minutes of math fluency/routines per day in grades K-3, and 30 minutes of Math response to intervention in elementary. This time includes two, network-paced math routines (quick images, number strings, what does not belong, number of the day) each week. The 2024-2025 school year was used to introduce and train teachers on these routines. We will continue this training, support, and implementation of paced math routines in this upcoming school year.

To enhance the core curriculum and provide rigorous and structured options for teachers, we utilize supplemental platforms such as [IXL](#), [Nearpod](#), [BrainPop](#), and [Standards Plus](#) as a part of our Response to Intervention framework. Academic intervention staffing, including SETSS, AIS, and tutoring, along with teacher assistants in grades K-2, tutors in grades 3-4, and Student Support Associates in grades 5-8 remains intact.

Kingsbridge will continue another year using its grant funding from the Robinhood Foundation to provide small-group targeted tutoring in a 4:1 ratio. GOAL 3: SCIENCE

All students at Amber charter will become proficient in science and will make strong yearly progress toward mastery of scientific skills.

BACKGROUND

Amber Charter Schools originally explored reinvesting in the McGraw-Hill science curriculum, but received feedback from many teachers and leaders that the McGraw-Hill’s curriculum was difficult to use, especially for new or less experienced teachers, and the online platform was lacking. As Amber staff continued to adjust to all the new changes taking place across the educational landscape after COVID, in addition to already adopting new curriculums in other content areas (like math at some schools, K-4 social studies at all Amber schools) for the 2023-2024 school year, we opted to select all HMH science curriculums. Seeing as Amber already uses HMH for math and reading, teachers and leaders would be familiar with the online platform and curriculum structure, supporting ease of training and implementation.

Additional reasons for selecting the three HMH science curriculums include:

Science Dimensions (K-4):

- Builds confidence with authentic investigations - each lesson begins with a problem to solve or event to explain
- Drives learning with ample hands-on activities and labs so students can think critically about their observations, practice gathering evidence, and defend their claims
- Follows a 5E lesson structure, which is familiar and predictable, supporting teachings of all experience-levels in planning and implementation
- Integrates STEM concepts into every unit, emphasizing engineering design as well as scientific literacy

Into Science Grade 5 and grades 6-8:

- A phenomenon-driven curriculum that delivers three-dimensional learning and incorporates the Claims, Evidence, and Reasoning model
- Includes hands-on activities that embedded social and emotional learning, as well as open-ended simulations that allow students to use technology, like a real scientist in the field
- Offered embedded, on-demand program training and week-by-week planning guidance build teacher confidence
- Provides differentiated instruction and remediation strategies for modifying existing activities or assigning new activities are available to provide extra, on level, extension, and ELL support
- STEM is integrated within and across the entire program

While students are not tested on the state level until grade 5, it is our goal to build strong foundational scientific understanding and skills in the elementary grades leading up to 5th grade. This will help ensure we are setting our students up for success. Investing in quality science curriculum, as well as professional development around science standards and cross-curricular connections, will help support students' acquisition of scientific skills in grades K-4. This is something we have already begun doing in the school year 2023-2024, as mentioned above, continued in the school year 2024-2025, and will continue to do in 2025-2026.

ELEMENTARY AND MIDDLE SCIENCE

Science Measure 1 - Absolute

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State science examination.

The school administered the New York State Testing Program science assessment to students in 5th and 8th grade in spring 2025. The table below summarizes the performance of students enrolled for at least two years.

EVALUATION OF THE SCIENCE GOAL

ADDITIONAL CONTEXT AND EVIDENCE

During the 2024-2025 school year, we offered a Regents-level science course to our Amber Kingsbridge 8th grade students for the first time. After seeing the great success of our Algebra 1 Regents course (90% passing in 2024 and 100% passing in 2025), we wanted to expand the opportunity for advanced Regents courses across content areas for our students. While the intent was clear, we faced some challenges that significantly impacted the Earth Science Regents passing rates for our Amber 8th Graders. We were also disappointed by the NYS Science test scores after years of high proficiency in the 4th grade exam before the 2024 switch to a 5th grade Science state test. While we will continue to make a concerted effort to raise overall science proficiency in 5th grade, we did make improvement from the previous year, growing from 34% proficiency on the 5th grade state test in 2024 to 42% proficiency this year. We are still waiting for the release of the city comparison data to evaluate the district and city's overall growth and performance from last year to this most recent test.

Two main barriers are listed below.



Curriculum: The Into Science Grades 6-8 curriculum covers the three main disciplines of life sciences, physical sciences, and earth and space sciences, aligned to the middle school NYS standards. We thought that we would be able to use the Earth and Space Sciences materials from this grades 6-8 curriculum to teach the Earth Science Regents course as long as we supplemented with the appropriate state required labs/lab hours. This was a mistake that led to the content on the Regent test itself being much more challenging and rigorous than the HMH content students were engaging with as the core component of their curriculum.

ACTION PLAN

Increase of middle school science minutes:

Grades 4-8 now have science for 45 minutes every day, and when schedules allow, 5th and 8th grade will have double blocks at least once a week to allow for extended lab time. This increase of academic minutes will allow teachers and students to dig deeper into scientific concepts, review previously taught skills, and provide additional time for hands-on experiments and applications. This focus on strong science instruction in non-testing grades (grades 4, 6, and 7), will help develop a stronger scientific foundation for when students are in the science state testing grades.

High school aligned curriculum: To ensure the curriculum from which we are teaching is rigorous enough and aligned to a Regents-level course, we have selected a true high-school level curriculum from HMH, Into Biology, to use this 2025-2026 school year.

Focus on life sciences: Biology: After talking more deeply with other middle school and high school peers, we learned that the Earth Science Regents course and exam is a highly specialized course, and that many middle schools instead offer a Regents science course more closely aligned with living environment, life sciences, and biology. For the 2025-2026 school year, we have opted to offer a Life Sciences: Biology course that will be aligned to the new Biology Regent.

Increased progress monitoring: While we administered mock assessments in 5th and 8th grade science last year, we are going to expand administering middle school science interim assessments in non-testing grades to help us better understand in which areas students need additional practice and support. Waiting until grades 5 and 8 to see these gaps in understanding is not setting our students up for success. We want to be more proactive and then responsive to the science data.

Staff support: Additionally, we are also improving our coaching, observation, and feedback systems to provide more frequent and targeted support for all staff. This will allow us to better monitor staff development, progress towards goals, and impact on student outcomes throughout the year.

We are hopeful that these intentional changes will not only increase proficiency scores in grades 5 and 8 this coming school year, but will also build a strong foundation of scientific knowledge across all grades from which we will continue to build.

GOAL 4: ESSA

ESSA Measure 1

Under the state's ESSA accountability system, the school is in good standing: the state has not identified the school for comprehensive or targeted improvement.

Because *all* students are expected to meet the state's performance standards, the federal statute stipulates that various sub-populations and demographic categories of students among all tested students must meet the state standard in and of themselves aside from the overall school results. As New York State, like all states, is required to establish a specific system for making these determinations for its public schools, charter schools do not have latitude in establishing their own performance levels or criteria of success for meeting the ESSA accountability requirements.
